PLAINTIFF'S RESPONSE TO DEFENDANTS' MOTION FOR PROTECTIVE ORDER

Defendants Broken Arrow School Board and Broken Arrow School District have filed a Motion for Protective Order regarding a subpoena seeking to obtain public records. Defendants suggest that the documents sought are not relevant and should be protected from discovery.

Plaintiff believes the documents are relevant.¹ These documents are public records and defendants lack authority to seek protection of the documents. Specifically, the documents have been made relevant by the defendants who are also counter claimants against the Plaintiff.

On May 14, 2012, defendants/counter claimants, Flippo, Whelply and Wilkins listed on their Witness and Exhibit List as Exhibit "1" documents which they subpoenaed from Windstream Corporation regarding 2007 Final Four tickets. (Defendants' Witness and Exhibit List attached as Exhibit "A"). In response to this listing, Plaintiff sought via

subpoena the underlying documents and contracts with Windstream Corporation which were held in the custody and control of Kellogg and Sovereign Consulting. The relevance of the documents was addressed in a discovery conference with Mr. Bo Rainey and in a letter from Plaintiff's counsel. Further, these documents are public records and not subject to any type of protective order.

Wherefore, Plaintiff respectfully requests that the Court deny defendants' motion for a protection of the public documents relevant to accusations and exhibits submitted by the defendants.
