Dear Board Members and Dr. Sisney,

This week has been very disheartening to Narissa, David and me. Earlier this week, an employee came to us with news a customer had told our employee that Air Assurance had been double invoicing the schools and overcharging them. Three other Air Assurance customers had made comments to the same degree. As you know, this matter was raised with us by you and we provided documentation that double invoicing and overcharging had not occurred.

A person, owning a business spends a lifetime building a reputation, earning respect and it can be so easily tarnished by rumors. In the last 24 years we have built a business where the very core values of our company are all about integrity, respect, and trust. We are proud to have become a part of this community, building relationships and serving the Broken Arrow schools.

I am sure that the rumors that are going around are not from this board or the superintendent. It is a large district with many employees and people do talk even when you ask them not to. I know it is impossible to control that. What you

can do is to put an end to the rumor mill by simply honoring our request made in the previous letter which puts an end to this once and for all, and might ensure that no further damage is done to our company, employees and us. We have met with all of the board members to show you that there was nothing we did wrong in the 3 examples that were brought to our attention and you were all satisfied with the conclusion. We also have asked that if there are any other questions to just bring them to our attention so that they to can be cleared up to everyone's satisfaction and so that there is nothing in question left unanswered. We are confident that no billing mistakes have been made, but in the unlikely event that a mistake did occur, it was unintentional and we have always told you that the mistake would be remedied. Having said that, we have a very high degree of confidence that no mistakes have been made and there is not evidence or indication to contradict our confidence.

We are not asking to do the work at the schools again but many of our customers are school employees and community leaders, and we have suffered a loss of business because of the false accusations having been made publicly and then repeated to others. We only ask you to please consider our requests to end this situation so that the better good of the schools, this community, our company and our team members can be done. Your assistance and understanding here is for the benefit of all and harms no one.
